**DEPOSITS** - A non refundable / non transferable deposit of \$50 is required at time of booking to secure your date, this amount is subtracted from the total package price. Payments can be made via Cash, Direct Deposit, or Money Order.

**CONFIRMATION** - Your session date will not be confirmed until your deposit has been received.

**PAYMENTS** - Final Balance of any package is due at the time of your confirmed session, or if agreed within 7 days into ACP nominated bank account. Images will not be provided until payment has been made in full.

**LIMIT OF LIABILITY** - In the unlikely event that Amy Campbell Photography is unable to complete your session due to an injury, illness, act of God, act of terrorism, or any other cause beyond the control of Amy Campbell Photography, responsibility and liability is limited to the return of all payments. In the unlikely event that digital files are lost, stolen, or destroyed for reasons beyond Amy Campbell Photography's control, liability is limited to the return of all payments received for your session. Any damages, injury or losses incurred by any means are not the liability or responsibility of the photographer.

**DIGITAL DELIVERY** - Unless otherwise specified, all images are delivered to Clients digitally. For example; USB media or online via pixieset.com. Amy Campbell Photography does not guarantee the archive or retention of images beyond 30 days once digitally delivered to Clients. Clients are therefore responsible for the download, saving and redistribution of images post delivery notification. Amy Campbell Photography is not responsible for client information technology assets. Clients are strongly advised to make a copy of their images for safe keeping. Clients are welcome to edit/copy/share/redistribute images as they see fit. Amy Campbell Photography takes no responsibility for outcomes post digital delivery. Images at this point are the property of the client and are their responsibility.

**CANCELLATIONS** - Cancellations for whatever reason will incur total forfeiture of \$50 deposit paid.
